I, Christian E. Cory, of lawful age and being first duly sworn on oath, depose and state:

Your Affiant is a Detective with the Wichita Police Department (WPD). In that capacity your Affiant was assigned to assist in the investigation of WPD case number 17C045837 and 17C060736 all of which occurred in Wichita, Sedgwick County, Kansas.

The identity of all individuals referenced herein are known to your Affiant. However, many individuals are referenced by initials only as Affiant believes that revealing their full names would jeopardize the safety or well-being of these witnesses. Revealing the full identity of all individuals referenced herein could also risk the destruction of evidence

On March 17, 2017 at 1720 hours, Carlo Brewer reports to WPD Officers that he hasn't seen his son, 3 year old Evan Brewer (dob: XX/XX/2014), for approximately 1 month. Carlo said he is concerned for Evan's welfare due to not seeing him. Carlo stated that Evan lives with, his mother, Miranda "Mandy" Miller and her boyfriend Stephen "Bo" Bodine at 2037 S. Vine. Carlo told Officers that on this evening he made contact with Miranda at the door. He said he saw Evan and it appeared his skin had been scraped off the front of his nose. Carlo advised that Bodine had been in contact with him via text message advising that he, Bodine, was now handling the visitation matters and told Carlo he wouldn't get to see Evan. Officers attempted contact at 2037 S. Vine and via phones for Miranda and Bodine with no answer. This case is documented under WPD case number 17C017775.

On July 6th, 2017, Carlo went to court and was granted full custody of Evan under Sedgwick County protection of abuse order case 17DM3140. Miranda did not attend this hearing and protection from abuse (PFA) orders were placed against Miranda and her live-in boyfriend Stephen Bodine preventing contact with Evan and granting sole legal custody to Carlo. A Wichita Police Department case was opened for interference with parental custody under 17C045837.

Sedgwick County Sheriff department personnel attempted to serve the PFA orders in person multiple times from July 6th, 2017 to July 17th, 2017, to Miranda and Stephen. On July 17th, 2017, at 1533hrs, they affixed the PFA orders to Miranda and Stephen's front door at 2037 S. Vine.

On August 18th, 2017, the landlord/property owner D.H. received a text from a number he believed to be Miranda's. The text stated that Stephen and Miranda were out of State with Evan.

On August 30th, 2017, Wichita Police Officer K. Bauman #1312 was contacted by BJ a neighbor of Miranda's and informed him that there was a UHAUL moving truck backed into the driveway of 2037 S. Vine. BJ observed Miranda and Stephen loading the UHAUL as if they were moving. Off. Bauman and Off. M. Nagy #1775 went to the location and observed the UHAUL in the driveway. They set up surveillance and waited for Miranda and Stephen to come outside.

Miranda left in her vehicle and was arrested for aggravated interference with parental custody under 17C045837. Miranda was alone in the vehicle and no car seats were observed. Officers then went to 2037 S. Vine to contact Stephen who came outside and was arrested for an outstanding felony pick up documented under 17C055237. Both Miranda and Stephen refused to give the location of Evan. Miranda did not speak to law enforcement.

The landlord of 2037 S. Vine filed an eviction action in Sedgwick County District Court on August 24, 2017. On August 30, 2017, DH was granted sole possession of the residence and an order was entered on September 1, 2017. On September 1st, 2017, the landlord/property owner DH had his attorney place the "Writ of Restitution" on the doors of 2037 S. Vine. At that time, possession was restored to DH.

On September 2nd, 2017, the landlord /property owner DH went to the location and started cleaning up the property. While working in the utility room located at the back of the residence he attempted to move a carpet covered platform that had tool boxes stacked on top of it. The platform was much heavier than DH expected so he removed the tool boxes and pulled off the carpet. DH found that the platform was a large block of concrete, with a wooden lower frame, and caster wheels. This block is large enough to encase a child's body. DH found the block hard to move and heavy. DH then drove to a tool store and purchased a sledge hammer to break the block open. DH returned to the residence and started hitting the block to break it open because he feared Evan was inside. DH struck the block breaking deeper into the concrete and was hit by a rotten odor emanating from the concrete block. DH believed that the smell was Evan's body so he stopped and called 911.

Off. Karen Blank #2293 arrived on scene and contacted DH. DH took Off. Blank to the utility room and showed her the concrete block. Off. Blank could smell a bad odor and observed flies landing on the cracked portion of the block. DH stated he was crying while he swung the sledge hammer because he feared Evan was inside and that the concrete block reminded him of a tomb. A search warrant was later obtained for 2037 S. Vine.

Your Affiant then conducted a post-Miranda interview with Stephen Bodine. Stephen said the he couldn't help us with Evan because he doesn't know where Miranda has him, but he is sure he is in safe hands. Stephen said he didn't know where Miranda has been since May and he doesn't ask. Stephen said Carlo had threatened to take Evan away but Miranda said they weren't going to get him. Stephen said he moved in after the court orders were final because he

found them taped to the door. Stephen said Evan was already gone when he moved in. Stephen said I don't believe that Mandy wouldn't let anyone keep that boy that wasn't stable and safe. Bodine said originally the concrete block was made for a burn thing to keep a fire pit off the grass. Your Affiant asked Stephen if Evan was inside the concrete block. Stephen said, "You wouldn't think so." Your Affiant asked again and Stephen stated a second time "you wouldn't think so."

During the search, the concrete block was removed and opened at the Sedgwick County Regional Forensic Science Center (SCRFSC). Inside the human remains of a child were located. The remains were wrapped in what appeared to be several layers. These layers included black tar/felt roofing paper, a fitted bed sheet with Ninja Turtle characters on it, grey duct tape, linoleum flooring, and bath towels.

The remains were taken by Medical Investigators of the SCRFSC. Dr. Kipper M.D. of the SCRFSC performed an autopsy on the remains of the child. The identity of the remains were confirmed to be Evan Brewer by the SCRFSC.

Det. J. Manuel #2151 spoke with Carlo Brewer on 09/02/17. Carlo said Evan began staying with him in January 2017 and even up to a week at a time. Carlo said that Evan was potty trained. Carlo said when Evan would return from time at Miranda's house and Evan would poop his pants. Carlo said Evan would hit and try and choke Carlo's other son. Carlo said that he questioned Miranda about possible abuse after his visit from Evan 6th through the 13th, 2017. Carlo said several days after that Miranda told him that he would never see Evan again and Bodine was now his dad. Carlo said Miranda told him that if he was allowed to see Evan again, it would only be if Miranda and Bodine allowed it.

Det. Manuel spoke with Carlo about text messaging he received from Bodine in February 2017. Your Affiant received text messages from Carlo Brewer that had been taken by screenshot, in reference to the interview with Det. Manuel. The messages were from 316-821-5907, a number associated with Miranda Miller in Wichita Police Department records. The messages received by Carlo on February 19, 2017 stated "I want to talk about the boy. This isn't Miranda. Its bk. Bo. Bo." They continued "...However; I want certain rules established...." "I have this phone on me unless she breaks free of my grasp again," and "so leave attitudes aside for the benefit of the boy." Bodine then discussed a visitation schedule with Carlo.

Your Affiant contacted ME. ME stated that Bodine used to live with her but he was kicked out in early 2017. ME said Bodine had not been living with her within the past couple of months. ME stated that she received a message from Stephen Bodine from phone number 316-444-0135. ME noted she could not call Bodine on this number, she could only text. ME had told Stephen, via text, to give Carlo his kid and move on with his life. Bodine responded, "Fuck you. The Pfa is bullshit. I don't need you. I was just hoping you would tell what I thought was the truth. He has no rights. He isn't getting shit other then a lawsuit." Both text messages were sent on August 19, 2017. Photographs were taken.

Your Affiant was contacted at a later time by ME. ME stated she found some of Bodine's things in her house. ME stated Bodine still had things at her house from when he was living at

her house, before he moved in full time with Miranda. ME stated that one looked like a list of rules. There was a list that included a notepad with the following writing. "Dad gets Evan ready and takes him to daycare." "Mom picks him up and ensures proper bed time procedures/rules care met." "Mom gets up on Sundays." "Dad gets up on Saturdays whenever Evan gets up." A horizontal line is drawn and the note continues, "Dad no longer worries about Brian or similar situations." "Mom act & behaves like a committed, happily married woman." Another horizontal line is drawn, "Dad tries to loosen up." "Mom tries to think before acting." One last horizontal line is drawn, "Evan is permitted in Kitchen (stays out of drawers, off counters away from stove & fridge.)" "Evan can control his tv/ DVD no others." The note continues on page two outlining daily chores for Mom and Dad and lists the name "Mandy" once in the chores instead of mom. The Note was photographed, recovered, and submitted as evidence by Off. D. Ice #2551.

Your Affiant contacted LL. LL stated she used to have an intimate relationship with Bodine when they lived together for four (4) years and she still kept in contact with him. LL stated she contacted Bodine at 2037 S. Vine on multiple occasions. LL said Bodine told her about physical violence inflicted on Miranda and LL witnessed verbal arguments. LL stated Bodine complained that Evan was scared of him, Evan would not look at him, would wet himself because he didn't want to pass any room Bodine was in. LL stated she has not had contact with Bodine since. LL stated that Miranda told her that she was pregnant. Later, possibly in February, Miranda told LL that Bodine had punched the baby out of her stomach. LL added that Bodine then told her that Miranda took pills and lost the baby. LL stated that during her relationship with Bodine he attempted to choke her, although she never reported the incident.

A search warrant was obtained for 2037 S. Vine on September 02, 2017. Detective J. Miller searched the southeast bedroom and he observed two sample books for linoleum flooring samples. The size and shape of linoleum found in the concrete block dismantled at SCRFSC with the human remains is the same.

During the search of the residence, bedding was located that had Ninja Turtle theme, including a sheet and comforter. Both appeared to be of the same style or from the same set of bedding to your Affiant.

During the search a receipt dated May 26, 2017 was located for the Westlake Ace Hardware located at 2559 S. Seneca Suite 10. This receipt documented the purchase of concrete, threaded rod, and a concrete trowel. The purchases were made via a Master Card. WPD Officers conducted follow up with the Ace Hardware and found that the receipt was signed by Miranda Miller. Your Affiant observed threaded rod embedded in the concrete while assisting in the disassembly of the concrete. Your Affiant also knows a trowel can assist with the pouring and or laying of concrete.

Your Affiant spoke with BS. BS is an ex-coworker and friend of Miranda Miller's. Miranda told BS that Bodine had at one point pushed Miranda to the ground and hit her. BS stated that Miranda said Evan would sit in his room and pee his pants instead of walking past Bodine to go to the bathroom. BS allowed your Affiant to view text messaging between BS and

Miranda that he said he received in February, 2017. The text messaging included messages to BS from Miranda stating: "...Bo came after me threw the window and busted it out hitting me giving me two black eyes", on 02/06; "...I'm seeing the female Dr to make sure everything is still OK and the hopefully setting up another appointment to get me fixed so there is never a chance of a second child for me.", on 02/05; "I really just went for pain pills both the bitch wouldn't give me any because I was pregnant and then 2 days later lost the baby which hurt worse then the fucking cut", 02/05;

Through search warrants served on tablet computers and mobile phones belonging to Bodine and Miller that were found inside 2037 S. Vine, your Affiant located an app on several devices called "WardenCam". Your Affiant knows that Warden Cam is a phone and tablet computer application that can use spare phones and tablets as cloud based security cameras. Your Affiant knows WardenCam also has motion detection capabilities. With Warden Cam you can watch your recorded videos or live streaming on a mobile telephone, tablet computer or on a cloud storage service, Google Drive, or Dropbox using a Wireless Fidelity (Wi-Fi) network. Your Affiant has viewed WardenCam and Picket videos that use the file name with year-month-day-hour-minute-second file names when they are created. Your Affiant has verified the accuracy of these time and date stamps on other files with other police record sources. Your Affiant also observed multiple Google accounts associated with tablet computers and mobile phones recovered from 2037 S. Vine and other witnesses.

Value Place Hotel at 4665 S. Broadway have Miranda and Bodine checking in on July 04, 2017 at 1936 hours. Off. R. West #2114 watched video surveillance at the Value Place Hotel until Miranda and Bodine leave on July 18, 2017 at 0437 hours. Off. West did not see a child with Bodine or Miller at any time while they were at the hotel.

Your Affiant contacted RF who said he spoke with Bodine while both men were incarcerated. RF said one day the little boy stopped eating. Bodine said the boy went to sleep and didn't wake up. Bodine told RF that Miranda slept all day and the kid had no adult supervision. Bodine told RF that he got rid of all the evidence and disposed of it all for her.

Your Affiant contacted JC. JC said he spoke with Bodine while both men were incarcerated. JC said Bodine told him Miranda called him several days after Evan died to help her get the body out of the house. Bodine told JC he was still using methamphetamine (meth). JC said Bodine also told him that Miranda would sleep while Evan gets up and runs all over the place. JC said Bodine told him that he loved the kid and tried to discipline him.

Your Affiant contacted L. Seigler of Chase County Sheriff's Office. While incarcerated in Chase County, Kansas in October, 2017, Bodine told Seigler that his wife's son died. Bodine said he came in and she was doing CPR. Bodine said he didn't even know CPR. Bodine told Seigler that the kid died probably from neglect. Bodine continued saying she [his wife] would go to bed about the time the kid was getting up and the kid was left to fend for himself. Bodine acknowledged he was the one who put the kid in the concrete in the laundry room.

On, September 23, 2017, Dr. Kipper M.D. of the SCRFSC performed an autopsy on Evan. Dr. Kipper listed the cause and manner of death as undetermined and undetermined,

respectively. Dr. Kipper also noted there was no gross anatomic cause of death along with, probable contusion of right posterior parietal scalp, possible contusion of right cheek, and possible right sided periorbital contusion. Your Affiant spoke to Dr. Kipper who explained that the body of Evan was so decomposed that any damage to the soft tissue of Evan's body, or his brain was not visible.

In March, 2017, Carlo Brewer made a report to Kansas Department for Children and Families (DCF). On March 24, 2017, Social Worker K. Battle of DCF spoke with Det. Bauman who stated Carlo Brewer reported Evan may have a broken nose. K. Battle had contact with Miranda and Evan at her office on March 24, 2017. Battle also noted Evan had a small abrasion on his back. Miranda told Battle that Bodine was her fiancé.

On April 22, 2017, Off. Bauman #1312 reported under DCF intake #1580827 that Carlo reported physical abuse going on at 2037 S. Vine by Bodine. Carlo reported Bodine beating on Miranda and dragging her across the house by her hair. Carlo reported that Bodine was giving Evan a bath, Evan fell back hitting his head which knocked Evan out.

On May 01, 2017, Battle contacted Bodine at 2037 S. Vine. Battle told Bodine she needed to speak with him. Battle reported Bodine replied "so," and closed the door.

On May 02, 2017, Battle had an office interview with Miranda. Miranda said that Evan was with Miranda's sister "Tonya Brown" in Oklahoma.

On May 04, 2017, Carlo Brewer made a report to DCF, which is documented under DCF case #303996 event #1584407. Brewer reported that he had last seen Evan on March 19, 2017, at which time, it looked like Evan had a broken nose. Brewer reported that LL, had reported that Bodine told her about choking Evan until he passed out and then giving him CPR to revive him. Brewer continued saying LL reported that Bodine told her he got Miranda to submit to him and he just has to beat it into Evan now. Brewer stated that LL told him she spoke with Evan and Evan told her he was scared to be at home and he acts like he is asleep when Bodine is in the home so he won't do anything to him. LL told Brewer that Miranda is hiding Evan so that nobody can see if he has injuries or not.

On July 17, 2017, the PFA granting custody of Evan to Carlo was taped to the front door of 2037 S. Vine by Sedgwick County Sheriff Department. PFA # 17DM3140

On August 03, 2017, Det. Manning D1738 contacted Bodine at 2037 S. Vine. Bodine showed Manning the three (3) PFA (17DM3140) orders that had been taped to the front door. Det. Manning advised Bodine he was served. Bodine told him Miranda and Evan were no longer staying at the residence. Bodine said Miranda is aware of the orders but had not been served.

On August 11, 2017, Carlo and Sara Kirby went and attempted to contact Miranda in reference to Evan. Sara said she had contact with Bodine. Bodine told Sara Miranda had moved out of state. Sara said when she asked again Bodine told her "I'm holding them hostage in my basement," in a sarcastic manner then told them to get off his property. This incident is documented under WPD case number 17C055220. Later in the evening while Carlo and Sara were attempting to contact 2037 S. Vine again, Bodine emerged with a hatchet approaching Carlo and damaged a tire on Carlo's vehicle. A felony pick-up was issued for Bodine under

aforementioned WPD case number 17C055237.

On September 02, 2017, Off. Perry #2432 contacted CB in the 2000 block of S. Vine. CB stated that she was often around Evan and in February 2017 she noticed Evan's behavior change. CB stated Evan began urinating and defecating on himself. She stated Evan had violent tendencies and attempted to choke her juvenile cousin with his hands and tried to choke Evan's cousin with a dog leash. CB said that Evan would never want to return home, with Miranda and Bodine, when she would drop Evan off at 2037 S. Vine. CB stated Evan was always tried to stay with her.

On September 02, 2017, Off. B. Knowles #2324 contacted MH in the 2000 block of S. Vine. MH, a neighbor of 2037 S. Vine, stated she last saw the child living at the 2037 S. Vine around the first week of July. She saw a child she believed to be Evan outside and viewed him from across the street.

On September 03, 2017, Det. McVay and Det. Miller spoke with EM. EM said she spoke with Miranda, in August 2017 via phone, after she saw the missing poster for Evan online. EM said Miranda told her she and Evan were not in Kansas. EM said she just wanted to know Evan was safe. EM said she never got to talk to Evan nor did she hear him in the background during her phone calls with Miranda. EM said she dropped some toilet paper and food off to Bodine at 2037 S. Vine and stood by the front door, in August 2017. Bodine told EM she could look through the house and she declined. EM said she never saw Evan, didn't see any toys, and she did not hear or see Evan. Bodine told EM he was being harassed. After leaving, EM called Miranda and asked her to post a picture of Evan or make it her profile picture. EM told Miranda that she was asking for a picture personally and Miranda sent her a picture of Evan. EM said the picture that was sent was a picture at nighttime, but their text conversation was during the day. EM said she hasn't seen Evan in a year.

On September 06, 2017, Det. Miller #1990 contacted SPB. SPB said that Bodine has a hair trigger when it comes to getting upset. SPB said he moved to Wichita with Bodine and SPB said that he and Bodine started doing meth in the last few years. SPB said he assisted Bodine and Miller in the sale of meth from 2037 S. Vine. SPB said he left Wichita in August, 2016 when Bodine threw him into a dresser breaking it. SPB said that he believed Evan was a hindrance and obstacle to Bodine and Miller's lifestyle.

On September 06, 2017, Det. Miller contacted VP. VP, Bodine's mother, said that Bodine has anger issues since he was young. VP said that Bodine did not like kids at all. VP said Bodine was terrible to his daughters and abused them. VP said Bodine told her that he tried to drown his daughter SJ in the bathtub when SJ was two years old then had to revive SJ using CPR. VP said that Bodine molested and abused SJ and his other daughter. VP adopted SJ when she was seven (7) years old. VP said that she traded a single family house to Bodine for custody of SJ and another daughter. VP said that Bodine used to trade drugs, crack cocaine at the time, so others could molest SJ.

Your Affiant conducted a records check with Peoria County, Illinois. Your Affiant requested and received a "Quit Claim Deed" from Peoria County, Illinois. The Deed transferred

the property commonly known as 5813 S. Adams Street, Bartonville, Illinois 61607 from James Phillips and Victoria Phillips to Stephen M. Bodine. The document is dated September 17, 2002 and stamped "FILED" 02-37530.

On September 11, 2017, your Affiant contacted IG, a former roommate of Miranda Miller. IG said he lived at 2037 S. Vine from the beginning of 2016 and then moved out later that year. IG stated that while he was living with her in 2016 she had purchased concrete for a basement repair. IG said he assisted with childcare for Evan. IG said that he was training Evan to use the bathroom instead of going in his diaper.

On September 11, 2017, your Affiant spoke with JK, a friend of Miranda's. JK said that sometimes Miranda wasn't a good mother, sometimes she was negligent, selfish and didn't take good care of Evan. JK said Miranda would sleep all day and let Evan run around the house and get hurt. JK said in the past she has watched Miranda around Thanksgiving (2016) because Miranda had to "go meet Bo." JK said that Miranda didn't return for three (3) days after that. JK said she would watch Evan when Miranda was at work and said Evan would cry when he had to go home. JK said while watching Evan she had to raise her voice to him a couple times in September, 2016. JK said that when she raised her voice Evan flinched and would cover himself with his hands as if really scared. JK said Miranda was showing up to their work "fucked up," which means she was high, and on this day she was on meth and Ambien. JK said that Evan fell down the stairs during the summer of 2016 and he had black and blue marks on his face. JK said she also saw cigarette lighter burns on his fingers often because he would play with lighters. JK said she last saw Evan around March 1, 2017. JK said she has never met Bodine but knew he was giving Miranda drugs. JK spoke with Miranda in the afternoon about two days before she was arrested on August 30, 2017. JK said Miranda told her she took Evan out of the state in both Oklahoma and Texas and wouldn't give him up. JK asked to talk to Evan. JK said Evan was with Bo at the house, then Miranda began crying and hung up.

Your Affiant conducted an interview of Bodine's daughter, SJ, who reported being the victim of multiple incidents of physical, mental and sexual abuse as a child while in the care and custody of Bodine. SJ advised that being violent, yelling, fighting and throwing things was a common behavior for Bodine, who was abusive to his children as well as women that he was in a relationship with.

SJ reported that one of the punishment's that Bodine would administer to her was to make her stand in the corner for unusually long periods of times -- some of which extended overnight into a second day of punishment. If SJ moved or fell asleep, she received additional discipline. SJ described that Bodine would hit her in the back of the head, causing her head to whip forward and strike the wall. Along with being made to stand in the corner for extended periods of time, Bodine would place SJ in her bedroom closet for long periods of time with the instructions to not make any noise. SJ reported that Bodine did not like crying children.

SJ told your Affiant that as a child she was terrified of water, recalling instances where Bodine would pour water over her head and face. SJ advised that when she turned nineteen years of age she had an electronic communication with Bodine. During the message, they got into an

argument, and Bodine told SJ that there were three instances that he held her underwater in the bathtub. Bodine told SJ that on two of the occasions, he held her underwater long enough that when he pulled her out of the water he had to perform CPR on her to revive her.

SJ advised that Bodine found joy in spanking, recalling how he would chase her and upon catching her would spank her with a belt. If a belt was not available, Stephen M. Bodine would grab whatever was in reach to strike her. SJ recalled a spatula and a hairbrush were two instruments used to administer spankings. While the intended placement of the spankings may have begun on her buttocks, the weapons inevitably ended up striking her in the back, resulting in injury. SJ advised that before going to school, she was normally dressed in long sleeves and pants, by Bodine to conceal the bruises she received from Bodine. SJ recalled there being days that she was not taken to school due to her injuries.

SJ reported there were instances when Stephen M. Bodine did not have the money to pay for his drugs, so he would allow adult males to sexually abuse her in return for the drugs. While the sexual assaults occurred her father, Bodine, would wait in the living room.

SJ advised that she witnessed Stephen M. Bodine beat his female companions, girlfriends, and/or DJ. She recalled her biological mother, DJ, as well as other females being drug by their hair throughout the house, culminating in punches and kicks. SJ stated, "He would beat the crap out of them". SJ stated that her grandmother, VP, traded a house for custody of SJ.

Your Affiant conducted an interview of Stephen M. Bodine's ex-wife, DJ, who reported that she became pregnant with Stephen M. Bodine's child, SJ, in 1994. DJ described Bodine as controlling and manipulative and has always surrounded himself with people that he can control. DJ reported that Bodine was verbally and physically abusive to her, citing one time that she almost died during a physical altercation.

DJ told your Affiant that during an argument with Bodine he punched her in the stomach, causing her to fall to the ground, and be unable to catch her breath. While on the ground, Bodine placed DJ into a "scissor lock", with his legs wrapped around her chest as he constricted her breathing. DJ stated that she eventually lost consciousness before Bodine released his grasp on her.

DJ advised that she was always in fear of Bodine, citing a time that he had friends over to the house and for no particular reason Bodine picked her up and body-slammed her to the ground. DJ advised that he would act in such a fashion towards her in front of others to show his dominance and control over her. DJ provided another example of Bodine's control over her, stating that Bodine would not allow her to leave the bed while they were sleeping - even to use the restroom. If she attempted to leave the bed, he would grab her and throw her back onto the bed. DJ recalled one time when she attempted to leave the bedroom to use the restroom that Bodine threw her onto the floor beside the bed and flipped the mattress over on top of her to pin her to that position on the floor. DJ stated, "He enjoyed hurting me. It was a power trip. It made him feel all-powerful".

DJ provided another example of Stephen M. Bodine's propensity for violence, explaining that she caught Bodine with another woman. During the argument, Bodine chased down DJ and

while in a physical altercation, twisted her arm behind her back and placed pressure on her wrist, resulting in a sprained wrist that required medical attention and a soft-cast. DJ advised that law enforcement was called and Bodine was arrested. Bodine was charged and went to prison for eighteen months. This incident is documented under El Paso (Illinois) Police Department case number 97-0180 which occurred on November 10, 1997.

DJ advised that Bodine has never been good with kids and did not like crying. DJ recalled that if the children were crying, Bodine would physically abuse them in order to, "give them something to cry about". DJ advised that the abuse to SJ and another identified juvenile became so extreme that Bodine's mother, VP, traded a home that she owned in Bartonville, IL for the two girls. DJ advised that once her daughters were in the custody of VP, the children began to disclose sexual abuse that they were the victims of at the hands of Bodine.

Your Affiant conducted an interview of JM, who was in a relationship with Bodine, after DJ. During their relationship, JM and Bodine had a child in common, GM. JM advised that she became pregnant with Bodine's child at age seventeen. JM began living with Bodine and began to assist in the raising of Bodine's two daughters, SJ and EP.

JM advised that when she was in a relationship with Bodine, EP was being potty-trained. Bodine was violent with EP whenever she would have a potty-training accident. JM recalled Bodine beating EP when she would have an accident. JM told your Affiant, "Sometimes she would try and run from him. And he would just snatch her up by the arms and sling her around and throw her into the bedroom. And he would start off by like picking up her legs and just smacking her as hard as he could on the butt. And he would pick her up... He would pick her up and fold her in half so that her head would meet her knees. And then he would slam her on the ground."

JM advised that after she had her son, GM, she went back to work and Bodine remained at home watching their son. She recalled coming home after work to find that GM had a bruise on the bridge of his nose and two black eyes. She questioned Bodine about the injuries and he told her that the baby was crying, so the only way to make the baby stop crying was to make the child cry harder. Bodine told JM that he began tapping on the bridge of the baby's nose really hard, repeatedly - until the baby cried so hard that the baby passed out. JM reported coming home on other occasions to find bruising on GM's buttocks and bruising that looked like hand prints.

Your Affiant served a search warrant to Google, Inc. for the account of "ballbuster67". Google listed the subscriber information to Miranda Miller, with the recovery email of "Evanbrewer67@gmail.com" that was created on January 23, 2017. On the return, your Affiant received a video labeled with file name indicating the date from May 19, 2017. Your Affiant observed a video of Miranda violently spanking Evan for moving while in bed. Miranda leaves then immediately returns when Evan moved his head, she strikes Evan again by bringing her arm above her head saying "I said don't move again." A male voice in the background identifiable states "if he don't want to listen..." then the words are unidentifiable.

Off. Mulloy #2440 and your Affiant looked at video and photos obtained via search

warrant from Google, Inc. The account associated with the video and photos are for the account of "balllbuster67". Google listed the subscriber information to Miranda Miller, with the recovery email of "Evanbrewer67@gmail.com" that was created on 01/23/2017. On file "event_2017_03_12_19_53_32.mp4". There is a video of Bodine talking to Miranda as Bodine walks downstairs. Bodine says "So every time I... it's the, the whole way its fucking emailing cuz its motion." Miranda responds in the affirmative. Bodine replies "So every fucking time he wiggles its motion." The video appears to take place inside of 2037 S. Vine and taken on a portable camera or device.

The next video observed from "balllbuster67" was "event_2017_03_12_19_54_00.mp4". The video is a continuation or a continuation with a short delay from previously mentioned file listed file. It depicts a young child's legs (standing) and exposed buttocks, nude from the waist down with a heavy chrome or metal chain that appears connected to the child and attached to something off camera. The child appears to be standing on a piece of cardboard on top of wooden pallets on a concrete floor next to a concrete wall. Once in the basement, Bodine and in proximity to the child says, "Here you go tough smart guy. Think you can hear me coming now, huh? Think you are so smart? I betcha you cant. Bet you you're not." Bodine appears to go back up a staircase then begins talking to Miranda "fucking emailing the whole damn time huh. Well I could have stopped it I guess, put my hand over the damn thing. Sorry, wasn't thinking about it." Miranda states "It's okay baby. It's okay baby. Ugh this little shit." The video appears to take place inside of 2037 S. Vine and taken on a portable camera or device.

Another video observed from "balllbuster67" was "event_2017_03_12_20_42_36.mp4". Starts out upside down then is moved to the right-side up position. The video shows a dark room looking at the back of a small child with curly and/or wavy hair. The child does not have a shirt on and appears to be standing. There is another shadow in the room visible on the wall that appears to be bald and holding what would look like a mobile smart phone horizontally while moving from spot to spot accompanied by digital sounds of a digital camera acknowledging a photo/or video was captured. There is no speech on the video.

The next video observed from "balllbuster67" was "event_2017_03_12_20_42_51.mp4". This video appears to be a continuation of the previously listed video from the dark room. This video continues in a dark room with a concrete wall. The child is facing away from the camera, appears to be standing without a shirt and his right hand and arm are behind his back near his lower back. It is not clear whether the child's arms are bound. There is another digital sound as the adult bald shadow on the wall appears to be holding a mobile smart phone horizontally and manipulating it. These actions are coupled with the aforementioned digital camera sounds. Your Affiant then hears Bodine's voice state "I'll find out what you are doing. I know you don't want to do anything I tell ya, but I would highly, highly, highly, highly, hi..." The video then stops."

The next video observed from "balllbuster67" was "event_2017_03_12_20_43_18.mp4". This video appears to be a continuation from the previous two videos in the dark room, the male moves shedding more light on the young boy. There appears to be a dark object around the boy's neck. The boy's right arm is still behind his back and it appears his left arm is also behind his



back in the same position with the hands and/or wrists coming together near the small of his back. The boy has no shirt on. Your Affiant then hears Bodine state "...right this very second. That you do not remind me you are in my house. Fucking sick of you dude. You can't win. You're not achieving nothing. You're losing every fucking thing; me, your mom, your...." The video then stops.

A still photo from "ballbuster67" was labeled "2017_03_12_19_28_18". The photo depicts Evan surrounded by concrete walls with what appears to be a dark, possibly leather belt around his neck. The belt has a metal buckle. Evan has no clothes on, the side profile of his buttocks is visible, and his arms and hands are behind his back. Whether Evan's arms or wrists are bound is unclear. The next photo is labeled "2017_03_12_19_28_52". There appears to be someone standing in front of the camera. The photo appears to be the same location as the previous picture with the back of Evan's head visible. Evan's left arm is in the same position behind his back. Evan has no shirt on. Another photo labeled "2017_03_12_19_33_46" appears to be a black and white photo showing what appears to be Evan in the same location as the previously listed photos. Evan still has the black belt with a metal on his neck. His hands are behind his back and his hands appear to be bound together. Evan has no clothing on other than the belt around his neck. Evan's buttocks is visible. This picture shows the same profile as the profile from the videos in the dark room that are identical to Evan. Another photo "2017_03_12_20_42_36" is photo that appears to be in the same location as the videos from the dark room. There appears to be the shadow of a bald headed figure. Evan's back is to the camera and he appears to have no clothing on with the right side of his buttocks showing. Another photo "2017_03_12_20_42_51" is photo that appears to be in the same location as the videos from the dark room. There appears to be the shadow of a bald headed figure. Evan's back is to the camera and he appears to have no clothing on with the right side of his buttocks showing. Another photo "2017_03_12_20_43_36" is photo that appears to be in the same location as the videos from the dark room. There appears to be the shadow of a bald headed figure. Evan's back is to the camera and he appears to have no shirt on.

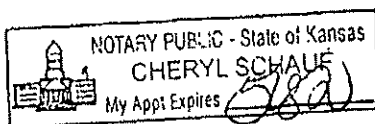


